
NUMANEWS GREENWAVE GIRLS SOFTBALL TEAM TAKES STATE CHAMPIONSHIP

Churchill County High School Wins 3A Softball Championship

Vernita Fillmore, Kalaya Downs and Janessa Bettencourt, honorably represented the Fallon Paiute Shoshone Tribe as the Churchill County High School varsity softball dominated the Northern Nevada 3A Regional and Nevada State 3A softball tournament to become the 2024 3A Nevada State Softball Champions.

On Saturday, May 18th, Churchill County and Fernley faced off for an all-north 3A state softball title. The Greenwave jumped out to a hot start, scoring two runs in the first inning. They continued to pile it on in the second inning. Freshman Layla Walker mashed a two-run homer after it tipped off a Vaqueros outfielder's glove going over the fence. The next at-bat, sophomore Janessa Bettencourt blasted a solo home run to center field, making it a nine run second inning. Starting pitcher and junior Vernita Fillmore (a tribal member of Fallon) dominated in the circle, pitching five innings and holding the Vaqueros to one run. Churchill County defeated Fernley 11-1 in five innings.

Throughout the season junior Vernita Fillmore, sophomore Janessa Bettencourt and freshman Kalaya Downs. (tribal member) made their marks in both offense and defense contributing to a solid Greenwave core. Vernita pitched (1.723 ERA) and played shortstop, Janessa pitched (2.16 ERA) and played 2nd base and Kalaya as a freshman worked her way up to start in right field providing solid defense behind her pitchers.

On offense Vernita was led off hitter finishing out the season with a .422 batting average with Kalaya .310 and Janessa .293 following behind respectably.



Vernita really shined in the post season where she led the Lady Wave to 2024 Regional and State titles by going 6-0 and only allowing 5 runs across the plate. The Lady Wave outscore their opponents 47-5 in these 6 playoff games. During the Regional Tournament in Spring Creek, Nevada May 9-11, 2024, Fallon marched through the winner's bracket defeating Fernley 7-1, North Valleys 5-1 and Fernley again in the Regional championship 13-0.

The 2024 Nevada State tournament was held in Fallon at the Edward Arciniega Athletic Complex May 16-18, 2024. Fallon came into the State Tournament as the No. 1 seed for the Northern region and where they met at defeated southern #2 seed Pahrump Valley 5-0. Fernley defeated Boulder City in their first game in the state tournament to set up a rematch with Fallon. Fallon defeated Fernley 6-2 sending Fernley for a rematch against Boulder City where Fernley picked up their second tournament win.

Saturdays Championship Title match was set up to be a rematch of regional tournament between Fallon and Fernley. Fallon shutdown the Vaqueros 11-1 in the five innings to win the 3A State Championship. Vernita Fillmore was also awarded "Player of the Year."

We are very proud of these ladies and the honor they brought to our Tribe and our community. Keep up the good work ladies and we cant wait to see what is next to come.

Churchill County wins its first state softball title since 2018 and its eighth in program history.

The current Tribal Chairwoman is only enforcing the DMV Vehicle Privilege for the benefit of federally recognized Nevada Native Americans residing permanently within the boundaries of the Fallon Paiute-Shoshone Reservation & Colony.

PLEASE:

 When you arrive at the Administration Building, 565 Rio Vista requesting a DMV Exemption, the Front Desk Staff will ONLY take a copy of your Valid Tribal ID, Drivers License & DMV Registration and/or Vehicle Title which will be picked up and processed by the Chairwoman's Office. Please leave a current phone number so the Chairwoman's Assistant can call you when your application is ready for pickup.

NOTE: ALL documents must match the same address located on FPST lands in order to validate the applicant & vehicle. If any of the documents do not match, it is the responsibility of the applicant to make necessary changes are done before receiving the exemption.

THERE IS A ONE DAY TURN AROUND FROM THE TIME YOU SUBMIT YOUR APPLICATION, SO PLEASE LOOK AT YOUR DMV EXPIRATION DATES CLOSELY & PLAN ACCORDINGLY.

The purpose of the program is to develop academic, occupational and literacy skills; to increase competitiveness in the workforce; to promote economic and social development; and to achieve personal and economic self-sufficiency for Native American, Alaska Native & Native Hawaiian individuals residing in the State of Nevada through employment and training activities. Eligibility Requirements – 1) Enrolled in the NWD Program, if not currently enrolled, contact NWD to make an appointment to enroll; 2) Be Native American, Alaskan Native or Hawaiian Native; 3) Reside on Reservation, Colony or Native lands; 4) Meet household income eligibility; 5) contact your Tribal Human Resources Office to see if your tribe is participating.

Required Documentation – 1) Picture ID/Age; 2) Social Security card; 3) Tribal Verification; 4) Proof of Residency; 5) Selective Service Registration (Males 18+ years only).

Income Eligibility - 1) Economically Disadvantaged, Proof of total family (household) income for the last 6 months (pay stubs, Public Assistance, TANF, SIIS, etc. 2) Unemployed; or 3) Underemployed.

DEPARTMENT OF MOTOR VEHICLE TAX EXEMPTION

This Governmental Services Tax Exempt Privilege/Eligibility has been in effect since 2012. The current Tribal Chairwoman is only enforcing the DMV Vehicle Privilege for the benefit of all eligible Tribal Members.

It is the responsibility of the Chairman/Vice Chairman of the Fallon-Paiute Shoshone Tribe to verify that the following vehicle tax exempt application through the State of Nevada is in accordance with NRS Nevada state requirements. The statement above the required signature of the Tribal Chairwoman states <u>"I declare under penalty of perjury that</u> <u>the foregoing is true and correct and that the applicant meets the eligibility requirements</u> <u>listed above."</u> This statement puts a great deal of responsibility on the Chairwoman & Vice Chairman under penalty of perjury to ensure the documents presented for exemption are true and correct. Likewise, the tribal member seeking the tax exempt also has an obligation by the statement above their signature, <u>"I declare under penalty of perjury that</u> <u>the foregoing is true and correct."</u> meaning the applicant attests all information is correct and has met the eligibility criteria when requesting the vehicle privileged exemption.

This privilege was created for the beneficial use & opportunity for federally recognized Tribal Members LIVING ON THE FALLON PAIUTE-SHOSHONE RESERVATION OR COLONY ONLY

INSTRUCTIONS & ELIGIBILITY:

- The exemption must be applied for annually with a separate exemption application required for each vehicle being registered.
- Bring your Tribal ID, Drivers License & DMV Registration and/or Title to the Chairwoman's Office for
 processing. ALL documents must match the same address to validate the applicant & vehicle. If any of
 the documents do not match, it is the responsibility of the applicant to make necessary changes.
- Once the proper documents are turned in, please give the Chairwoman's Office at least 24 hours time for processing.

WHO IS NOT ELIGIBLE:

 Fallon Paiute-Shoshone Tribal Members or other Nevada Tribal Members who <u>DO NOT</u> permanently reside within the boundaries of the Fallon Paiute-Shoshone Reservation or Colony are NOT ELIGIBLE for receiving the Governmental Services Tax Exempt from the Fallon-Paiute Shoshone Tribe.







Paiute-Shoshone Tribe will receive \$2.5M for affordable housing

Nevada Appeal-

Seventeen tribal communities across Nevada, including the Fallon Paiute-Shoshone and Walker River Paiute tribes, will receive almost \$27 million in grants from the U.S. Department of Housing and Urban Development for the development and operation of affordable housing.

Fallon will receive about \$2.3 million while Walker River has been approved for more than \$4.3 million.

this federal funding that will provide families with the support and resources they need to improve their quality of life," said U.S. Sen. Catherine Cortez Masto, D-Nev.

Cortez Masto said federal funding has already supported new tribal housing across Nevada, including new middle-class family homes in Owyhee and Washoe Valley in just the past year.

"The housing crisis in Nevada is impacting everyone in our state, especially tribal communities," said fellow Democratic U.S. Sen. Jacky Rosen. "I'm proud to announce this funding for affordable housing development for tribes across Nevada. I'll keep working to bring more federal investments to ensure that tribal communities have the resources they need."

Cortez Masto secured \$4.8 million in 2022 from the Federal Home Loan Bank of San Francisco to support Nevada affordable housing organizations including tribes, and to cut through red tape to make it easier to build affordable housing across the state.


